Pizza.io Privacy Policy

Pizza.io takes protecting your privacy very seriously.

We implement suitable technical and administrative controls in our endeavours to keep your personal information protected at all times. Our Privacy Policy lays out how your personal information is handled. We ask that you please read through it, as by using our services you agree to accept the terms.

Personal Information is any information that allows you to be identified and may include your name and address, date of birth, payment details and any other information you may wish to provide or that is collected about you. We will take measures to ensure that use of your Personal Information is compliant with data protection and privacy regulations valid in the countries where we operate. This Privacy Policy applies to Personal Information we collect when you use our websites or when you otherwise interact with us.

The controller of the personal data is Moon Technologies B.V.

Purpose for the collection of personal data

Your personal information is collected and used for the following reasons:

- To provide you with our services
- To contact you in case you win something
- To make more of such services available to you where possible and appropriate
- For the purposes of security and control
- To satisfy regulatory and legal requirements
- For historical and statistical purposes
- To notify you about updates to our software or services.

We may further use your personal information in order to contact you from time to time, to introduce you to our products or any events, activities, projects, plans, developments, undertakings and special offers that are taking place, being promoted or supported by Pizza.io. We may contact you via email.

When you supply us with your personal information, you are agreeing that you do not consider our use of such personal information - in accordance with this Privacy Policy -

as any breach of your rights under the Data Protection Act (Governed by the law of Curacao).

At any time, you have the right to opt out from receiving any promotional and/or marketing materials that we may send you. You are encouraged to contact us should you wish to do so.

Disclosing personal information to third parties

Pizza.io policy is that your personal information will not be disclosed to anyone other than employees of Pizza.io that require access to your data in order to provide you with a service, with the exception where Pizza.io may be required by law or legal process to disclose your personal information to relevant authorities.

However, we may disclose Personal Information to government institutions if it is required by law.

Protection of your personal information

Pizza.io employs physical, electronic and managerial procedures to safeguard the security of the data you provide to us. SSL encryption is used on our website for all sensitive data. Pizza.io advises you to take any and all precautions you can to protect your personal data while using the Internet.

Personal Information will be kept as long as the data is needed to provide the services and stipulated by the law. The customer has the right to ask for Personal Information to be deleted, however, in some cases we may refuse to delete data based on the law.

Should the aim of processing of Personal Information data change, we will inform you as soon as possible. Should there be a need for consent from customers, we will acquire that from you accordingly.

Access to your personal information

You have the right to access any information we hold about you at any time. You may contact Pizza.io service department at Pizza.io and ask for details of any information we hold about you. You have the right to request any incorrect information to be corrected, or where applicable, removed. Pizza.io reserves the right to ask you for a written request for any information we hold about you.

Cookies

A cookie is a data packet which is used solely for web analytic purposes. Our website uses cookies to recognise visitors. Cookies used by Pizza.io are only set if the user agrees, and expire within a maximum of four weeks.

Privacy Commitment

In order to ensure that your personal information remains confidential, our privacy guidelines are communicated to every employee of Pizza.io. Where the website of Pizza.io contains links to other sites, Pizza.io does not share your personal information with those sites and is in no way responsible for the privacy policies of those sites. We would advise you to make yourself aware of the privacy policies of any such site. If our privacy policy changes and we plan to use your personal information in a way that is different from that stated to you at the time of collection, you will be informed accordingly.
